SUPPLEMENTAL DECLARATION TO AMENDED AND RESTATED COMMUNITY DECLARATION FOR DEL WEBB ORLANDO AT RIDGEWOOD LAKES

THIS SUPPLEMENTAL DECLARATION TO AMENDED AND RESTATED COMMUNITY DECLARATION FOR DEL WEBB ORLANDO AT RIDGEWOOD LAKES (this "Supplement") is made this by day of May, 2011, by Pulte Home Corporation, a Michigan corporation (the "Declarant").

RECITALS

- By virtue of that certain "Assignment of Declarant's Rights" recorded on February 2, 2010 in O.R. Book 8067, Page 2020 of the public records of Polk County, Florida, Pulte is the "Declarant" under that certain Community Declaration for La Cresta at Ridgewood Lakes, recorded in OR Book 7143, Page 1339 of the public records of Polk County, Florida (the "Original Declaration"), as amended by that certain First Amendment to the Declaration for La Cresta at Ridgewood Lakes, recorded in OR Book 7214, Page 2260 of the public records of Polk County, Florida (the "First Amendment"), the Supplement to Community Declaration for La Cresta at Ridgewood Lakes, recorded in OR Book 7378, Page 1519 and re-recorded in OR Book 7427, Page 634 of the public records of Polk County, Florida (the "First Supplement"), the First Amendment to Declaration for La Cresta at Ridgewood Lakes, recorded in OR Book 7508, Page 1000 of the public records of Polk County, Florida (an "Amendment"), the Assignment of Declarant's Rights-La Cresta at Ridgewood Lakes, recorded in OR Book 7976, Page 808 of the public records of Polk County, Florida (the "Assignment"), the Certificate of Third Amendment to Community Declaration for La Cresta at Ridgewood Lakes, recorded in OR Book 8067, Page 2039 of the public records of Polk County, Florida (the "Third Amendment"), and the Amended and Restated Declaration for Del Webb Orlando at Ridgewood Lakes, recorded in OR Book 08161, Page 2191, of the public records of Polk County, Florida (the "Amended and Restated Declaration"). This Supplement, together with the Amended and Restated Declaration shall be collectively referred to as the "Declaration."
- B. Article XI, Section 11.1 of the Declaration provides the Declarant may, from time to time, subject to the Declaration all or any portion of the property described in Exhibit "B" of the Declaration by Recording a Supplemental Declaration describing the property being subjected. Further, Article VI, Section 6.4 provides that such

Supplemental Declaration may create and designate Neighborhoods within the Community.

- C. The real property described in **Schedule A** of this Supplement is part of the real property described in Exhibit "B" of the Declaration.
- D. Declarant wishes, in accordance with Section 11.1 of the Declaration to file of record this Supplement for the purpose of subjecting the real properly legally described in **Schedule A** to the provisions of the Declaration. Further, Declarant wishes, in accordance with Section 6.4 of the Declaration to create and designate such real property as a Neighborhood.

NOW, THEREFORE, Declarant hereby amends and supplements the Declaration as follows:

- 1. The foregoing recitals are true and correct and form a material part of this Supplement. The foregoing recitals are incorporated herein by this reference.
- 2. Capitalized terms used herein shall have the meanings ascribed to such terms in the Declaration unless otherwise defined herein.
- 3. The Declaration is hereby amended by the addition of the real property described in **Schedule A**, attached hereto and incorporated herein by this reference, which real property shall hereafter be part of the Property and subject to each and every term, condition, covenant and restriction of the Declaration as it exists and as it may be amended from time to time.
 - 4. The following Neighborhood is hereby designated by this Supplement:

Lots 1 through 45, RIDGEWOOD LAKES VILLAGE 9, according to the map or plat thereof as recorded in Plat Book 152, Page 15, Public Records of Polk County, Florida (the "Vista Chino Neighborhood").

- 5. The Declaration, as amended, is hereby incorporated by reference as though fully set forth herein and, except as specially amended hereinabove, is hereby ratified and confirmed in its entirety.
- 6. This Supplement shall be effective immediately upon its recording in Polk County, Florida.
